Texas law does not require embalming. However, it is the policy of a Cremation that any non-embalmed human remains may not be viewed, unless such viewing is required for the purpose of positive identification. Further, it is the funeral home's policy that no unembalmed body is dressed prior to placement in a casket or other burial container in clothing other than that which death occurred.)
